

Procedure of Our Fabric Inspection:

| SL | Process | Procedure |
|-----|--------------------------------|---|
| 01. | Fabric Receiving | Fabric inspector receives the total quantity of knit fabrics here. |
| 02. | Manual Fabric Inspection | Here, fabric inspector inspects the fabrics manually. Normally we apply 4 points inspection method. |
| 03. | GSM checking | Fabric GSM has to check by maintaining buyer's instruction using GSM cutter. |
| 04. | Shade Checking | Fabric shade has to check here by following buyers approved shade. |
| 05. | Confirmation of fabric quality | After completing all the above inspections, quality inspector confirms here the actual quality report of knitted fabrics. |






Our Sewing Flowchart:


